### Notes of Guidance for Parents on Admission to Post-Primary Education (Year 8) 2024/25

The usual age group for application is pupils who will be 11 years old by **1 July 2024** (those dates of birth between **2 July 2012 and 1 July 2013**). Pupils who were retained for an extra year in Primary School can also apply and, in exceptional cases, underage pupils if agreed by the Board of Governors of their Primary School.

**Children with a Statement of Special Educational Needs** have a separate admissions procedure where the Post-Primary school placement is discussed with the parent as part of the review of the child's statement. Therefore, application **should not** be made on this form or through the Post-Primary Application Portal. You can contact your local EA Special Education Department for more information or the SEN Helpdesk on 028 9598 5960.

You cannot apply on this form for a place in an **Independent School**. Please contact the school directly.

It is important to read the admissions criteria for the schools you are listing as preferences and to attach any documents that schools have indicated are required for your child's application to be considered. Admissions criteria is available for all schools on the Education Authority's website at www.eani.org.uk/admissions.

How do I apply for a post-primary school place? Online applications closed 12 noon on 22 February 2024, to submit a late application you can fill in the application form attached to these notes of guidance. You should complete only <u>ONE</u> application form and on it list <u>ALL</u> the schools where you would be willing to accept a place. You should state clearly the published name and locality of each school you are listing.

Applying to an Integrated School - If you list an integrated school(s) as a preference you will need to check carefully its admissions criteria and ensure that you provide the details of your child's community background. If you list an integrated school(s) as a preference, please ensure you complete this section on the application form as this information is required by integrated schools to apply their balance. If applying online this information will only be visible to integrated schools that you list on your online application. However, if applying using a paper form, all information you provide, including that relating to your child's community background, will be visible to any school listed as a preference on your paper form which considers the application. If, when applying on a paper form, you wish to keep your community background private from other schools, you should contact the integrated school(s) you wish to apply for, to find an agreed alternative method of providing this information e.g. some integrated schools may have a separate pro-forma that you can complete and submit directly to the school.

**How many schools should I nominate?** You should nominate at least **four** schools and include at least one non-grammar school or your child may be at greater risk of being unplaced at the end of the process. At this point the choice of schools with places remaining will be limited. You may need to list more than four schools if the schools you are nominating are normally oversubscribed. For over 65% of those children who had not gained a place at the end of the 2023 admissions process, only one to three preferences had been listed on the application.

The closing date for late applications is 4pm on Monday 4 March 2024.

Applications submitted after 4pm on 4 March will not be processed until after the issue of placement notifications on 18 May 2024.
